Tri-State Pays System or Appliance EEA Pays

Electric Heat Pump - Air Source

Rebate Incentives - Base

- \$85 per unit for terminal units (PTACs similar to the typical under-window hotel room units)
- \$125 per ton for central air source "split" or "mini-split" (ductless) units with electric resistance back up
- \$150 per ton for central air source "split" or "mini-split" (ductless) with non-electric back up

Rebate Incentives - Additional

- \$100 per unit additional incentive for Energy Star rated from 15 SEER thru 16 SEER
- \$150 per unit additional incentive for Energy Star rated above 16 SEER

Electric Heat Pump – Ground Source

Rebate Incentives – Base

• \$250 per ton for ground source systems such as residential or commercial ground source closed loop or ground water source

Rebate Incentives

- Full-size Energy Star® Certified Refrigerators and Freezers \$30 per unit
- Refrigerator and/or Freezer Recycling \$60 One week only April 17 22, 2017
- Energy Star® Certified Clothes Washers \$40 per unit for front load washers
 - \$30 per unit for top load washers
- Energy Star® Clothes Dryer \$30 per unit for clothes dryer
 - \$90 per unit for hybrid clothes dryer (ventless)
- Energy Star® Certified Dishwashers \$20 per unit



EEA matches Tri-State on appliances but does not match recycling a refrigerator or freezer

Electric Water Heaters

Rebate Incentives

- Basic Unit 30 -55 gallon resistance water heaters \$30 per unit
 - \$20 additional per unit with lifetime tank warranty, 30 gallon to 55 gallon only
- Ground source heat pump powered or desuperheater (waste heat) \$100 per unit
 - \$25 per unit additional incentive for lifetime tank warranty on heat pump waste heat units
- Heat Pump Water Heater (air to water and may have a back-up resistance element)
 - Residential units must be Energy Star® rated and commercial installations are open to all systems.
 - \$350 per unit 30 gallon minimum

Residential LED Lamps

Rebate Incentives

- LED lamps and LED fixtures over 500 lumens
- 50% of lamp or fixture cost
- Capped at \$8 / lamp (or fixture)
- Maximum of 50 lamps per account per year
