RATE CHANGE UPDATE – A RATE REDUCTION!

hange is a constant in our world, and as your electric cooperative we work to adapt while focusing on safely delivering reliable and affordable power to your home and business. The seven cooperative principles help us maintain that focus and this month we are seeing two of those principles in practice. The first is "cooperation among cooperatives." Tri-State Generation and Transmission Association, Empire Electric Association's wholesale power provider, is also a cooperative. Tri-State has been working on several requests from its membership including keeping power costs as low as practical. At the end of April, Tri-State announced something rare in the utility business: a rate reduction.

Tri-State's efforts at managing the cost to deliver reliable and affordable power to its member cooperatives lead to the second principle, "members' economic participation." One benefit to you as an EEA consumer-member is sharing in the economic benefits of being a cooperative. When EEA's costs go down, your costs go down. Tri-State's rate decrease will result in a reduction in EEA's expenses, and EEA plans to pass on this reduction directly to you in two ways.

First, we will reduce the purchased power components in our new rates that are scheduled to become effective September 1, 2021. The new rates will still incorporate the rate structure changes we have been addressing over the past several months. As noted previously, the new structure is designed to recover costs more fairly, to give consumer-members more opportunities

to save on their power bills, to better align costs with revenue streams and to be revenue neutral. Now, the new rates will also reflect the Tri-State rate decrease. The accompanying tables (page 6) show the updated rates.

Second, we will credit consumer-members their portion of EEA's realized savings between March 1, 2021, (the retroactive effective date of the Tri-State decrease) and September 1, 2021, (the scheduled effective date of EEA's new rates). This credit will be applied to the September billing statements.

Residential, General Service Single-Phase and Irrigation members will have the option of an all-energy rate or a new time -of-use-and-demand rate (TOUD). General Service Three-Phase members will have the option of a new TOUD rate or the Large Power rate.

For the new TOUD rates, the on-peak period is from 12 p.m. (noon) through 10 p.m. daily, Monday through Saturday, with the exception of the following six holidays if occurring on Monday through Saturday: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day. The off-peak period is any time that is not on-peak. Distribution demand is defined as the maximum average kilowatt load used by the consumer-members for any period of 15 consecutive minutes during the period for which the bill is rendered.

These changes are scheduled to go into effect on September 1, 2021. Consumermembers in rate classes that have the TOUD option will be automatically changed to that rate unless EEA is notified. Notice may be

You will be afforded the opportunity to change to a different rate any time after the September 1, 2021, effective date. Any subsequent rate change requests will only be granted after a minimum of one year on that rate.


